- (a) All collection agent/bailiff agency licences expire on December 31st;
- (b) All collection agent/bailiff employee licences expire 1 year from the date of issue;
- (c) All fees and charges will increase by 2%, on each year anniversary of the effective date noted above; some rounding may occur;
- (d) Application of fees for items 4-7 above is based on gross annual collections of the agency during the previous fiscal year or part thereof.
- (e) The renewal application fees for those applications submitted within two weeks prior to licence expiry will take effect on January 1, 2018. The renewal application fee for applications submitted more than 2 weeks prior to licence expiry will be in effect for all renewal applications received prior to January 1, 2018.
- (f) Fees for applications for new licenses will be prorated by the Authority in accordance with the following table:
