18. Subject to note (a)(c) below, for a licence to operate a theatre that exhibits to only one person at a time motion pictures that are classified as adult/restricted
 - c) for the first licence

 - where that application is submitted within 2 weeks prior to licence expiry.....\$285.00
 - d) for each additional licence at the same location
 - where that application is submitted more than 2 weeks prior to licence expiry.....\$57.00

Motion Picture Classification Fees

19. For a DCP-format motion picture, submitted under section 2(1) of the Act
 - a) for review and certification of each minute or part thereof\$2.08
 - b) for certification of each copy minute or part thereof\$1.04
20. Subject to note (b) below, for a motion picture, other than DCP-format, submitted under section 2(1) of the Act by a licensed motion picture distributor operating on a for-profit basis
 - a) for review and certification of each minute or part thereof\$2.08
 - b) for certification of each copy minute or part thereof\$1.04
21. Subject to note (b) below, for an advertising trailer submitted under section 2(1) of the Act by a licensed motion picture distributor operating on a for-profit basis
 - a) for review and certification\$10.40
 - b) for certification of each copy\$10.40
22. For an adult motion picture submitted under section 3(1) of the Act
 - a) for review of each minute or part thereof\$3.70
 - b) for certification of each copy\$2.00
23. For review of a motion picture intended for distribution to video retailers only.....\$52.00

Other Fees and Charges

24. Application for reconsideration of a decision, order or seizure\$242.00
25. Recording a change of licensee's name or licensed location address\$57.00
26. Recording a change in directors/officers/shareholders of the licensee\$57.00
27. Charge for submission of an NSF or declined credit card payment\$55.00

NOTES:

- a) All licences expire at midnight one year from the date of issue.
- b) Non-profit societies registered with the province of BC, Canadian charities registered with the Canada Revenue Agency, and local governments in BC are not considered as operating on a for-profit basis.
- c) Fees will increase by 2%, on each year anniversary of the effective date noted above; some rounding may occur.
