

FEE SCHEDULE

Home Inspectors

(Effective April 1, 2018)

The following fees, charges and other amounts, set by Consumer Protection BC under section 179(1) of the *Business Practices and Consumer Protection Act* S.B.C. 2004 C.2 (the Act) are payable by a "home inspector" (as that term is defined in the Home Inspector Licensing Regulation) to Consumer Protection BC in respect of the matters described opposite the fees, charges or other amounts:

1.	subject to Note (a)-(e) below, fee for a new application for a licence for a home inspector

2.	subject to Note (a)-(d) below, fee for a renewal home inspector licence application where that application is submitted more than 2 weeks prior to the expiry

4.	fee for an application for reconsideration of a Director's decision
5.	fee for recording a change of licensee's name or licensed location address

7.	subject to Note (c) below, charge for a laminated ID card in respect of a licence renewed for a home inspector (please provide a b/w or colour passport photo)

NOTES:

- (a) All licences expire on March 31st
- (b) Licence fees will increase by 25% and other fees and charges will increase by 2%, on the commencement of each calendar year following the effective date noted above; some rounding may occur;
- (c) Laminated ID cards will be provided upon renewal. Photo ID will be provided for a charge when requested;
- (d) The renewal application fees for those applications submitted within two weeks prior to licence expiry will take effect on January 1, 2019. The renewal application fee for applications submitted more than 2 weeks prior to licence expiry will be in effect for all renewal applications received prior to January 1, 2019.
- (e) Fees for applications for new licenses will be prorated by the Authority in accordance with the following table:
