**WHEN SUBMITTING THE COMPLETED APPLICATION PACKAGE, PLEASE ENSURE THIS CHECKLIST AND THE APPLICABLE FORMS AND DOCUMENTS ARE INCLUDED:**

- A completed application form. Please indicate your proposed licence type.
- Include your British Columbia registration forms for an incorporated company and registration forms for each trade name/dba, partnership or proprietorship. These can be obtained through BC Registry Services. Please ensure that you comply with *Business Corporations Act* in British Columbia regarding extra-provincial registration.
- A completed criminal record check for senior corporate officers, partners, or proprietor.** ALL APPLICANTS that reside in Canada MUST complete an online criminal record check within one day of sending the licence application to Consumer Protection BC by going to the following link: <http://www.sterlingtalentsolutions.ca/Consumer-Protection-BC> and following the instructions for completion. (Please note, once complete a copy will be sent directly to Consumer Protection BC. ALL APPLICANTS that do not reside in Canada MUST submit a certified criminal record check from their home jurisdiction.

**Note: criminal record check is required only if you are applying to exhibit, rent, sell or distribute adult films or video.**

- A copy of your current municipal business licence if you are applying as a restricted theatre, adult film retailer or distributor from inside British Columbia. It should clearly indicate that the retailing and/or distribution of adult video products are included in your local licensing, or it can also be in the form of a letter from the local government body to the retailer confirming that the zoning bylaws sanction the proposed activity. It is your responsibility as a licensee to ensure that suitable municipal zoning and licensing for your business are in place prior to applying.
- Submission of the applicable application fee payable to **Consumer Protection BC**. Licence fees are located in the fee schedule included in the application package or online at [www.consumerprotectionbc.ca](http://www.consumerprotectionbc.ca) . Please include a cheque, money order or the Credit Card Authorization form with your application.
- If the application is for an adult film distributor licence where decals will be affixed to adult films from outside of British Columbia, acceptable security in the amount of \$10,000. Please call 1 888 777-4393 for details.

Film Classification licenses are registered to one entity and are non-transferable. Application processing time is approximately 2-3 weeks.

Licenses are issued for one year and expire on the anniversary day of the issuance of your first licence. Prior to this, an application for renewal, with the applicable fee must be submitted. Renewal notification will be sent to the licence holder approximately six weeks prior to the licence expiry date.
