Columbia for a payday loan: 14% of the principal;

For a \$300 loan for 14 days:

Total cost of borrowing = *[the payday lender's total charges for a \$300 loan for 14 days];*

Annual Percentage Rate = *[the annual percentage rate charged by the payday lender for a \$300 loan for 14 days] per year;*
